## A Few Words From the Rabbi...

# Passover: Asking the Right Questions

Rabbi Paul David Kerbel

The Nobel prize-winning physicist, Isidore Rabi, once explained how he became a scientist. When he would come home from school, his mother did not ask him, "what did you learn today?" but rather, "Izzy, did you ask a good question today?"

To be a Jew is to ask questions. Our rabbinic tradition is based on asking questions about a word or verse in the Torah, or debating an aspect of law with pointed questioning. To be a Jew really means that we are a religion that encourages us to struggle with our beliefs, to act on our passions, and to strive to understand our relationship with God and our tradition.

Where does this passion for questions come from? Ultimately, it may come from our celebration and observance of Passover. In the Book of Exodus, the Torah describes a number of situations where children may come and ask us (the parents) to explain Jewish ritual and customs to them. Based on these verses, the Haggadah presents to us "the four questions" and "the four children." The central focus of the Passover Seder is to explain our traditions and history by encouraging our children to participate by asking questions.

The "Four Questions" is one of the most special moments of our seder. For some of us, our children or grandchildren are reciting them for the first time. In other homes, there may not be any young children, and teenage or college students are often embarrassed that they still have to recite the questions. But a number of scholars have pointed out that we have been misinterpreting the idea behind the four questions. It is not the mastery of these ques-

tions that is so important. These questions were meant to be examples of the types of questions we can ask at the seder. In fact, the Mishna, our first code of Jewish law (c. 200) states that if children are too young to ask (spontaneous) questions, it is the father who teaches (questions like) the four questions, which are not really formulated as questions but as statements of wonder, encouraging the children to ask even more questions. The Talmud indicates that those at the seder can ask any question that stimulates discussion and allows us to act as free people.

So this year, I would like to assign to all of us a homework assignment. I would like to encourage you to take some time to prepare carefully the spiritual side of your seder. What will you include and what will you leave out? Where can you linger for a few extra moments with questions and commentary? And I would especially like you to prepare in advance four additional questions that you would like to ask or to discuss after we recite the traditional four questions. The haggadot of the secular, nonreligious kibbutzim of the 1930s in pre-state Palestine give us some examples: "Why do people all over the world hate the Jews?" "When will there be peace and brotherhood the world over?" Let's go around the table. Let's linger a bit. Let's ask new questions: questions about Passover, questions about the Exodus, questions about the Torah or Jewish tradition, questions about Jewish survival and Jewish continuity, questions about Tikkun Olam and the lessons we learn from the Passover experience. Like Isidore Rabi, let us ask "Did I ask a good question today?" Questioning is truly a sign of freedom and crucial to re-enacting the Passover experience.

Melissa, Sam and Aliza, Judah and Eliana, Micha and I wish you a meaningful and spiritual Passover!

## TBEMC Religious School Provides Education for All Age Groups

The TBEMC Religious School fosters love for G-d, prayer, Torah, and community. We offer a range of Jewish education for the entire family. Religious School is Sundays from 9-12 for all grades, and Tuesdays from 4-6 for 3rd-7th grades. When students reach Bar/Bat Mitzvah, they will have learned skills in Hebrew reading, prayer and understanding of Jewish holidays.

Students begin in kindergarten through 2nd grade with hands-on learning that includes holidays and Hebrew letters. Temple membership is not required until 3rd grade. With our new Sustaining Pledge Model, more young families are joining an earlier time, because we have a more flexible donation model without a set dues amount.

The Gan Katan class held bi-weekly for ages 3-4, is filled with joy through art, music, storytelling, dancing and friendship. Temple membership is not required for this program, which begins the foundation of Jewish life for each child.

Tot Shabbat for children 0-6 years is held monthly and helps light a spark that connects children to Judaism at a young age. We develop the habit and joy of praying with the community. Temple members and non-members are warmly welcomed.

Parents are encouraged to enhance their Jewish education through Shabbat Junior Congregation and Sunday morning prayer service.

We welcome you to register throughout the year for Gan Katan through 7th grade classes. Any time you decide to register is the right time! We recognize that there are traditional and non-traditional family units with unique spiritual needs. It is our goal to open our doors to all who seek a congregation such as TBEMC.



## Torah Fund
